

DECISION
ADB(D)-11-2011

on the adoption of implementing rules to the staff regulations

THE ADMINISTRATIVE BOARD OF THE SESAR JOINT UNDERTAKING (SJU),

Having regard to:

1. The Staff Regulations of Officials and Conditions of Employment of Other Servants of the European Community, laid down by Council Regulation (EEC, EURATOM, ECSC) No 259/68¹, and in particular to Article 110 of the Staff Regulations;
2. The Council Regulation (EC) n° 219/2007 of 27 February 2007 on the establishment of a Joint Undertaking to develop the new generation of the European air traffic management system (SESAR) as modified by Council Regulation n° 1361/2008 of 16 December 2008² and in particular Article 2a thereof;
3. The decisions of the European Commission setting up implementing rules for the application of the amended Staff Regulations of Officials and the Conditions of Employment of other servants of the European Community;
4. The opinion of the Staff Committee and the agreement of the European Commission pursuant to article 110 of the Staff Regulations;

Whereas:

1. It is necessary, following Article 110 of the Staff Regulations for agencies to adopt the appropriate implementing rules for giving effect to these Staff Regulations, after consultation of the relevant Staff Committee and in agreement with the European Commission.;

In its ordinary meeting of 15 December 2011, HAS DECIDED AS FOLLOWS:


Article 1
