

# DECISION ADB(D) 11-2012

# Approval of the modification of the European ATM Master Plan

# THE ADMINISTRATIVE BOARD OF THE SESAR JOINT UNDERTAKING (SJU),

### Having regard to:

- Council Regulation (EC) n°219/2007 of 27 February 2007 on the establishment of a Joint Undertaking to develop the new generation of the European air traffic management system (SESAR) as modified by Council Regulation n°1361/2008 of 16 December 2008<sup>1</sup>, hereafter the "SJU Regulation";
- Article 5.1(a) of the Joint Undertaking Statutes annexed to the SJU Regulation;
- Article 8.1 of the Administrative Board's Rules of procedure;
- The SJU's proposal for the modification of the European ATM Master Plan of 10 May 2012;
- The approval in principle of the proposal for the modification of the European ATM Master Plan given by the Administrative Board on 3<sup>rd</sup> July 2012, subject to:
  - the inclusion of the comments expressed by the Administrative Board members; and
  - the finalisation of the European Commission's procedures to adopt the EU's position on the proposal;

## Whereas:

- The final version of the proposal to modify the European ATM Master Plan takes into account the majority of the changes agreed at the 22<sup>nd</sup> Administrative Board meeting held on 3<sup>rd</sup> July 2012;
- The European Commission confirmed in writing on 17 October 2012 the EU's positive opinion on the SJU's proposal for the modification of the European ATM Master Plan 2012, subject to taking into account a number of requests, as reflected in the Commission's Implementing Decision C(2012)6943;
- Some comments formulated by the Administrative Board Members, in particular by the European Commission in the aforementioned Decision, require additional work, in particular on the Business View chapter of the modified European ATM Master Plan, and that this work should be finalised in early 2013;

#### HAS DECIDED AS FOLLOWS:

## Article 1

The proposed European ATM Master Plan 2012 annexed to this decision is hereby approved.

#### Article 2

The SJU shall submit to the Administrative Board in early 2013 an addendum to the European ATM Master Plan hereby approved with the objective to address the comments formulated by the Administrative Board Members that have not been integrated.

This decision shall enter into force on the date of its adoption.
