

# DECISION ADB(D) 16-2013

### Implementation of the Staff Regulations to the SESAR Joint Undertaking

# THE ADMINISTRATIVE BOARD OF THE SESAR JOINT UNDERTAKING (SJU),

#### Having regard to:

- the Staff Regulations of Officials and Conditions of Employment of Other Servants of the European Union, laid down by Council Regulation (EEC, EURATOM, ECSC) No 259/68<sup>1</sup>, as last modified<sup>2</sup>;
- the Council Regulation (EC) n° 219/2007 of 27 February 2007 on establishment of a joint undertaking to develop the new generation European air traffic management system (SESAR) as modified by the Council Regulation n°1361/2008 of 16 December 2008<sup>3</sup> and in particular Article 2a thereof and Article 7 of the Statues;

#### Whereas:

- The Regulation n° 1023/2013 of the European Parliament and of the Council of 22 October 2013 shall apply to the SESAR Joint Undertaking as of 1 January 2014<sup>4</sup>,
- Specific Decisions or General Implementing Provisions may be necessary for the implementation of Regulation n° 1023/2013, in compliance with article 110 thereof.
- By the date of the Board meeting, the Commission has not adopted yet the appropriate decision or General Implementing Provisions for the implementation of Regulation n°1023/2013 that shall be applied by analogy to the SESAR Joint Undertaking.
- In the interest of the SESAR Joint Undertaking staff, the continuity of services shall be guaranteed,
