3. Upon receipt of the call for interest documentation, please send an acknowledgement of receipt to the Points of Contact.
4. You are aware that electronic transmission is not secure transmission and it may be read by third parties.
5. EUROCONTROL accepts no responsibility whatsoever for the completeness, accuracy and/or timeliness of the transmission of the electronic documents (nor for the electronic documents themselves).
6. Paper copies of the call for interest documentation, which are available upon specific request, shall at all times prevail.
7. Submission of registrations of interest shall **not be made electronically** and shall be exclusively made in strict accordance with the instructions given in the call for interest documentation.
8. You may:
 - a) print out the documents;
 - b) forward the documents further on a strictly need to know basis (always fully acknowledging the source, i.e. EUROCONTROL), and
 - c) use print-outs of the electronic call for interest documents for the submission of the registration of interest.
9. You may not:
 - a) modify, edit and/or change the electronic documents;
