

SESAR Joint Undertaking and EUROCAE sign Memorandum of Cooperation

Amsterdam, 7 March 2012. The SESAR Joint Undertaking (SESAR JU) and the European Organisation for Civil Aviation Equipment (EUROCAE) are pleased to announce the signing of a Memorandum of Cooperation to facilitate exchange of technical and programme information between the two organisations.

This Memorandum of Cooperation has been signed by Patrick Ky, Executive Director of the SESAR JU, Patrick Souchu, Chairman of the EUROCAE Council and Abdoulaye N'Diaye, Secretary General of EUROCAE, following its approval by the EUROCAE Council and the EUROCAE President, Jean-Paul Platzer.

EUROCAE will better align its strategic work programme to fit the standardisation needs of the Single European Sky. EUROCAE Working Groups will in return be better supported by additional SESAR information and involvement from JU partners. EUROCAE will also benefit from information coming from SESAR validation activities when needed in the life cycle of EUROCAE Documents (EDs) and EUROCAE Technical Specifications toward the development of Community Specification and European Norms. As a consequence this agreement brings significant benefit, helping to accelerate the development of EUROCAE standardisation material and technical specifications relevant to the Single European Sky.

Patrick Ky said at the signing ceremony that a vital element of the SESAR programme was to develop interoperable solutions for the global aviation community. Cooperation with standardization bodies was vital step to reach this goal.

According to Abdoulaye N'Diaye, this Memorandum of Cooperation is a major milestone towards a better alignment of EUROCAE activities with the Single European Sky objectives and timeline, a larger involvement of the aviation industry to SESAR and its future deployment and contributions to ICAO global ATM modernisation initiative.
