### DECISION GB(D)05-2021

#### SESAR 3 Joint Undertaking's Anti-Fraud Strategy 2021-2022

THE GOVERNING BOARD OF THE SESAR 3 JOINT UNDERTAKING ("SESAR 3 JU"),

Having regard to:

- Council Regulation (EU) 2021/2085 of 19 November 2021 establishing the Joint Undertakings under Horizon Europe and repealing Regulations (EC) No 219/2007, (EU) No 557/2014, (EU) No 558/2014, (EU) No 559/2014, (EU) No 560/2014, (EU) No 561/2014 and (EU) No 642/2014<sup>1</sup> ("Single Basic Act"), and, in particular, its Articles 18(4)(q), 28 and 174(9),
- Communication from the Commission C(2011) 376 to the European Parliament, the Council, the European Economic and Social Committee, the Committee of the Regions and the Court of Auditors on the Commission anti-fraud strategy (CAFS),
- Communication from the Commission C(2019) 196 to the European Parliament, the Council, the European Economic and Social Committee, the Committee of the Regions and the Court of Auditors on the Commission anti-fraud strategy: Enhanced action to protect the EU budget 29.4.2019,
- The SESAR 3 JU Financial Rules adopted by the Governing Board under Decision GB(D)01-2021 and, in particular, their Articles 14, 19, 24, 33, 40 and 58,

Whereas:

- (1) The SESAR 3 Anti-Fraud Strategy sets out a set of objectives and actions to address risks identified during a fraud specific risk assessment performed in Q4 2019.
- (2) Annex I to this decision was drafted and adopted through ADB(D)04-2020 by the Administrative Board of the SESAR JU, of which the SESAR3 JU is the legal and universal successor in respect of all contracts and grant agreements, liabilities and acquired property as per Article 174.9 of the Single Basic Act.
- (3) Annex I provisions shall be read and applied *mutatis mutandis* taking into account the new applicable legal framework.
