# DECISION GB(D)18-2021

## Transfer of the decisions of the SESAR Joint Undertaking's Administrative Board laying down implementing rules to SESAR 3 Joint Undertaking

### THE GOVERNING BOARD OF THE SESAR 3 JOINT UNDERTAKING ("SESAR 3 JU"),

#### Having regard to:

- Council Regulation (EU) 2021/2085 of 19 November 2021 establishing the Joint Undertakings under Horizon Europe and repealing Regulations (EC) No 219/2007, (EU) No 557/2014, (EU) No 558/2014, (EU) No 559/2014, (EU) No 560/2014, (EU) No 561/2014 and (EU) No 642/2014<sup>1</sup> ("Single Basic Act") and in particular articles 17.2 (v) and 174.12,
- The Staff Regulations of Officials of the European Union ('Staff Regulations') and the Conditions of Employment of Other Servants of the European Union ('CEOS'), laid down originally by Council Regulation (EEC, Euratom, ECSC) No 259/68 as last modified<sup>2</sup>,

#### Whereas:

- (1) The SESAR 3 JU Governing Board shall adopt implementing rules for giving effect to the Staff Regulations and the Conditions of Employment of Other Servants in accordance with Article 110(2) of the Staff Regulations.
- (2) In its first meeting, the Governing Board of the SESAR 3 JU shall adopt a list of decisions adopted by the Administrative Board of the preceding SESAR JU that shall continue to apply for the SESAR 3 JU, established by the Single Basic Act, and as set forth in its Article 174.12,

#### HAS DECIDED AS FOLLOWS:

#### Article 1

To adopt the list of decisions of the Administrative Board of the SESAR JU on implementing rules for giving effect to the Staff Regulation and the Conditions of Employment of other Servants that shall continue to apply to the SESAR 3 JU, as identified in Annex I of the present decision.
